Conducted by VIP Vacation Newsletter, the contest « Win a Trip for 2 » will run from May 9th 2019, to November 8th, 2019 inclusively.

1. ELIGIBILITY

This contest is open to legal residents of Québec, 18 years and over. Employees, travel agents and representatives, departments, affiliated companies, parent companies, their respective advertising and promotional agencies, rate, product or service providers related to this contest or anyone directly linked to this contest as well as their immediate families (mother, father, sisters, brothers, children), legal or common-law spouses and any individual with whom these employees, representatives and agents reside.

2. PARTICIPATION

No purchase required. To participate, the general public will be asked to register online to the VIP Vacation Newsletter contest. To be registered to the contest, participants will need to fill out an entry form. A name will be drawn at random from all eligible entry forms received. In the final draw, the winning entry will be drawn among all entries registered.

3. DRAW

Official contest draw: November 9th, 2019 12 h 00.

- 3.1. Anyone who wishes to register more than once to the contest by using different e-mail addresses, home addresses or other information allowing multiple registrations under the same will automatically be disqualified. The winner will have to provide proof of residence, legal IDs and his/her contact information must be identical to that appearing on the winner's entry form. Should the personal information on the entry form shows any type of discrepancies, the prize shall be forfeited.
- 3.2. To be declared a winner, the selected entrant for the prize must be reached by telephone or e-mail by the contest organiser within forty-eight (48) hours following the draw. If the selected entrant cannot be contacted by e-mail or telephone, then he/she will forfeit his/her prize and an alternate winner will be selected.

4. GRAND PRIZE

Vacation package for 2, product provided and selected by Transat.

Does not include:

Taxes and service fees; costs related to passports, tourist cards, visas and inoculation certificates; excess baggage charges; airport taxes and transportation related fees, local departure taxes in some destinations, goods and services taxes or other similar taxes; fuel surcharges or other charges imposed by the air carrier; travel insurance; return transfers between residence and airport; personal expenses; and excursions are the sole responsibility of the winner.

5. VALUE OF PRIZE

The organisers hereby declare that the approximate value of the prize offered for this contest is as follows: Maximum value of the trip for 2 persons including taxes is up to \$3,000. The winner agrees to abide to the politics, rules and/or restrictions applicable, as described hereafter.

6. GENERAL CONDITIONS AND RESTRICTIONS

- 6.1. VIP Vacation Newsletter will contact the winner by telephone and/or by regular mail and will e-mail or fax him/her their waiver letter. To claim his or her prize, the winner must present a photo ID that has to be valid when claiming its prize, and sign Declaration and Release Form, failing which it would be void.
- 6.2. The winner and his/her travelling companions shall indemnify and hold harmless their affiliates, franchisees, parent companies, affiliated companies, employees, agents and representatives for any damage whatsoever, including but not limited to, as a result of an accident, injuries, death, loss or delay of luggage or personal items, delay, complications, loss of enjoyment, annoyance, disappointment, anxiety or frustration either physical or mental that may occur by accepting or using the prize. Once declared a winner, the selected entrant to the prize agrees to sign a Declaration and Release Form.
- 6.3. The prize must be accepted as described herein and may not be substituted or exchanged for any other prize.
- 6.4. The persons on behalf of whom the contest is held shall accept no liabilities whatsoever for any situation in which their inability to act is the result of an event or circumstance that is beyond their control, from any malfunction of any communication line or of a strike, lockout or any labour dispute at their location or the locations of the organisations or companies whose services are used for holding this contest.
- 6.5. Any participant to this contest agrees to comply to these official rules and regulations and with the decisions of its authorised representatives, which decisions shall be final and shall be enforceable in all respects.
- 6.6. By entering this contest, the selected entrants authorise the organisers and their representatives, if applicable, to use their name, photograph, likeness, statements related to the prize, place of residence and/or their voice for advertising or promotional purposes, as needed, without compensation.
- 6.7. Any litigation respecting the conduct or organisation of a publicity contest may be submitted to the *Régie des alcools, des courses et des jeux* for a ruling. Any litigation respecting the awarding of the prize may be submitted to the Régie for the sole purpose of helping the parties reach a settlement.
- 6.8. The organisers of this contest reserve the right, at their sole discretion, to cancel, end, amend or suspend this contest in whole or in part in the event of virus, computer bug, unauthorised human intervention or any other causes beyond the control of the organisers which could corrupt or affect the management, security, impartiality or normal operation of this contest, subject to approval by the *Régie des alcools, des courses et des jeux du Québec*, if necessary.

6.9. This contest is subject to all applicable Federal, Provincial and local laws.

7. PRIZE CLAIM

The stay is valid for one (1) year from the date the winner has been drawn.

Black-out dates apply (winner cannot be at destination on or during the following dates): weeks of construction holidays, Christmas and New Year, Spring Break and Easter. Booking must be made at least one (1) month prior departure.

- 7.1. When making the reservation, the winner and his/her travel companions must have a valid passport, in effect six (6) months beyond the travellers' date of return to their country of residence.
- 7.2. The winner's travel companions must travel with the winner, at a chosen date, or the trip will be cancelled. Once the booking has been confirmed, cancellation or modification of travel dates will not be accepted. As well, travellers' name may not be changed.
- 7.3. This package may not be redeemed for cash and is not transferable.
- 7.4. Any expense other than those specifically described above are the sole responsibility of the winner or his/her travel companions; including cost of transfers between the travellers' residence and the airport, meals and beverages, taxes, cost of passport, visa, inoculations and other travel documents if needed, travel insurance and personal expenses.
- 7.5. No compensation will be offered should the trip be cancelled, in part or in whole, for reasons beyond the control of the organisers (natural or weather disaster, riot or political situation that might endanger the lives of the passengers, strike or other forms of crisis) and/or should the organisers' contractual obligations with its suppliers do not allow repayment of amounts already paid to the supplier on behalf of the winner.
- 7.6. The organisers do not accept any liability for any claim, loss, damages, costs or expenses arising from any accident, injuries, death related to the damages; loss or delay of luggage or any other personal item; or delays, setbacks, loss of enjoyment, physical or mental frustrations, All the terms and conditions of participating wholesalers and partners are in effect. Vacation package is according to availability at the participating wholesaler partner and according to the availability of flights and rooms at the time the request is made.
