

# RULES "THE VIP VACATION NEWSLETTER"

Organized by VIP Vacation newsletter, the "Win a stay for 2 with Transat at El Beso Adults Only at Ocean El Faro in Punta Cana" contest runs from December 30, 2024 to June 30, 2025 inclusive.

# 1.ELIGIBILITY

1. This contest is open to individuals aged 18 and older residing in Quebec, Alberta, British Columbia, Prince Edward Island, Manitoba, New Brunswick, Nova Scotia, Ontario, Saskatchewan, Newfoundland and Labrador, as well as the three federal territories of Northwest Territories, Nunavut, and Yukon. Employees, agents, and representatives of travel agencies, divisions, affiliated companies, parent companies, their advertising and promotional agencies, prize suppliers, products or services related to this contest, or any other party directly involved in the organization of this contest, as well as their immediate family members (father, mother, brothers, sisters, children), legal or common-law spouse, and all persons with whom these employees, representatives, and agents are domiciled, are excluded.

## 2.HOW TO PARTICIPATE

1. No purchase necessary. To enter the contest, the public will be invited to register online at the VIP Travel Bulletin contest. Participants must register by completing the entry form. One name will be randomly drawn from all entries received. The finalist will be drawn from all entries during the final draw.

#### 3.DRAW

Official draw date: July 17, 2025, at 10:00 AM.

- Any person entering the contest more than once in any manner, such as using different email addresses, residential addresses, or other information enabling multiple entries under the same name, will be automatically disqualified. Winners must provide proof of residence, official identification, and contact details that match the winner's entry form data. If the form contains anomalies regarding personal information, the prize will be forfeited.
- 2. To be declared a winner, the selected participant must: Be contacted by email or phone by the organizer within forty-eight (48) hours following the draw. If the selected participant cannot be reached by phone or email within forty-eight (48) hours following the draw, all rights to the prize will be forfeited and another entry will be drawn.

#### **4.GRAND PRIZE**

- 1. Travel booking must be made at least thirty (30) days before the projected departure.
- 2. Travel insurance, vaccination fees, airport taxes, seat selection fees, and personal expenses are not included in the prize.
- 3. The trip must be completed by October 31, 2025 (return flight must occur no later than this date).
- 4. Certain periods of the year are excluded: Christmas, New Year's Day, Easter holidays, and any other embargo period determined by Air Transat.
- 5. Air Transat's general terms and conditions available on the Air Transat website apply, including in case of cancellation due to health reasons or otherwise. No postponement is possible once the booking is made (please consult the Air Transat website).
- 6. Reservations are subject to Air Transat flight availability.
- 7. In case of unforeseen circumstances, Transat reserves the right to change the travel dates by a few days after informing the winner.
